The Crimes Code at 18 Pa.C.S. § 6105 (a) prohibits persons convicted of any of the following offenses under Title 18, or any equivalent offense under the statutes of any other state or of the United States, from possessing, using, controlling, selling, transferring, or manufacturing a firearm in the Commonwealth of Pennsylvania. A conviction includes a finding of guilty or the entering of a plea of guilty or nolo contendere, whether or not the judgment has been imposed, as determined by the law of the jurisdiction in which the prosecution was held. The term does not include a conviction which has been expunged or overturned or for which an individual has been pardoned unless the pardon expressly provides that the individual may not possess or transport firearms. The prohibited offenses as enumerated in subsection (b) are as follows:

The Crimes Code at 18 Pa.C.S. § 6105 (c) also prohibits the following persons from possessing, using, controlling, transferring, manufacturing, or obtaining a firearm in the Commonwealth of Pennsylvania:

- (1) A fugitive from justice.
- (2) A person who has been convicted of an offense under the Act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, or any equivalent Federal statute or equivalent statute of any other state, that may be punishable by a term of imprisonment exceeding two years.
- (3) A person who has been convicted of driving under the influence of alcohol or a controlled substance as provided in Title 75, Pa.C.S. § 3731 (related to driving under influence of alcohol or controlled substance) on three or more separate occasions within a five-year period.
- (4) A person who has been adjudicated as an incompetent or who has been involuntarily committed to a mental institution for inpatient care and treatment under section 302, 303, or 304 of the provisions of the Act of July 9, 1976 (P.L.817, No.143), known as the Mental Health Procedures Act.
- (5) A person who, being an alien, is illegally or unlawfully in the United States.
- (6) A person who is the subject of an active protection from abuse order issued pursuant to 23 Pa.C.S. § 6108 (relating to relief), which order provided for the confiscation of firearms during the period of time the order is in effect.
- (7) A person who was adjudicated delinquent by a court pursuant to 42 Pa.C.S. § 6341 (relating to adjudication) or under any equivalent Federal statute or statute of any other state as a result of conduct which if committed by an adult would constitute an offense under sections 2502, 2503, 2702, 2703 (relating to assault by prisoner), 2704, 2901, 3121, 3123, 3301 3502, 3701, and 3923.
- (8) A person who was adjudicated delinquent by a court pursuant to 42 Pa.C.S. § 6341 or under any equivalent Federal statute or statute of any other state as a result of conduct which if committed by an adult would constitute an offense enumerated in subsection (b) with the exception of those crimes set forth in paragraph (7). This prohibition shall terminate 15 years after the last applicable delinquent adjudication or upon the person reaching the age of 30, whichever is earlier.

18 U.S.C. § 922 (g) prohibits the possession of a firearm by any person who:

1. was convicted of a federal crime punishable by imprisonment for a term exceeding one year;
2. was convicted of a state crime punishable by imprisonment for a term exceeding two years;
3. is a fugitive from justice;
4. is an unlawful user of or addicted to any controlled substance;
5. has been adjudicated a mental defective or committed to a mental institution;
6. is an illegal alien;
7. has been discharged from the military under dishonorable conditions,
8. has renounced his or her United States citizenship;
9. is subject to a court order restraining the person from harassing, stalking, or threatening an intimate partner or child of the intimate partner; or
10. has been convicted of a misdemeanor crime of domestic violence.
